

ORDINANCE No. 184592

* Authorize an Intergovernmental Agreement with Multnomah County to continue funding mental health services at the Gateway Center for Domestic Violence Services (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. FY 2008-09 Adopted Budget includes a budget of \$422,000 in General Fund Ongoing and \$1,765,000 in General Fund One-time for the One-Stop Domestic Violence Center. The above funding is budgeted in the Commissioner of Public Affairs' Office.
2. The Center--now known as the Gateway Center for Domestic Violence Services--opened on September 8, 2010.
3. Since opening, more than 900 unduplicated survivors have accessed services at the Gateway Center, during more than 2000 visits.
4. The viability of the Gateway Center depends on a having a robust array of both private and public service providers on site.
5. Mental health services have been provided at the Gateway Center with one time funding by Multnomah County. That funding is depleted.
6. Mental health services are extremely important and valuable to survivors of domestic violence. At the Gateway Center, mental health services are requested and accessed at higher rates than the Department of Human Services Self Sufficiency services (which includes emergency monetary relief). Similarly, more survivors request and access mental health services than prosecution and police combined.
7. The City of Portland has identified a one-time operational savings in the current fiscal year of \$12,800 that can be applied to extend the current contract through June 30, 2011.
8. Multnomah County has identified temporary funding stream of \$12,800 to continue the service through June 30, 2011.
9. An agreement with Multnomah County is necessary to jointly support the continuation of the current contract with the existing qualified mental health provider.

NOW, THEREFORE, the Council directs:

- a. The Commissioner of Public Affairs is hereby authorized to enter into an agreement with Multnomah County to support the continuation of mental

health services for survivors of domestic violence at the Gateway Center for Domestic Violence Services in a form substantially in conformance with Exhibit A.

- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the General Fund, in payments as delineated in the attached agreement, which shall not exceed a total of \$12,800.
- c. In the event the agreement is extended by both parties pursuant to the terms outlined in Exhibit A and additional funds are identified in FY 2011-12, the Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the General Fund up to an additional \$33,500.

Section 2. The Council declares an emergency exists because delay in proceeding with this agreement will unnecessarily interrupt the provision of vital mental health services at the Gateway Center for Domestic Violence Services; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
