ORDINANCE No. 184616

*Exclude employees in five classifications from the classified service. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. City Charter Chapter 4, Article 3 provides that employees in classifications with a major role in policy formulation that requires independent judgment may be excluded from the classified service at the recommendation of the Human Resources Director and with the approval of Council by ordinance, if the employees are hired after the effective date of such ordinance.
2. The Human Resources Director finds that employees in the classifications listed below have a major role in policy formulation that requires independent judgment and recommends that employees in such classifications be excluded from the classified service if they are hired after the effective date of this ordinance.


NOW, THEREFORE, the Council directs:

- a. Employees in the following classifications are excluded from the classified service if they are hired after the effective date of this ordinance:
