

**ORDINANCE NO. 184641**

\* Amend subrecipient contract with JOIN for \$25,000 to provide additional housing placement for women experiencing homelessness (Ordinance; amend Contract No. 32000479)

The City of Portland ordains:

SECTION 1. The Council finds that:

1. The City of Portland passed Ordinance No 184012 authorizing Subrecipient Contract No. 32000479 with the JOIN to coordinate and administer a collaboration of experienced homeless services providers and new partners to deliver rapid permanent housing placement for people experiencing homelessness in streets, shelters, and transitional housing in Portland's central city.
2. Funding in the amount of \$25,000 in City general fund will be added to this contract through amendment for a total two-year not to exceed amount of \$845,000 through the allocation of existing appropriations in PHB's FY 2010-11 Ending Homelessness Initiative budget.
3. The additional funds will be used to rapidly house women who are experiencing homelessness.

NOW, THEREFORE, the Council directs:

- a. The Bureau Director and the City Auditor are hereby authorized to amend Subrecipient Contract No. 32000479 with JOIN in accordance with the amendment attached as Exhibit A.
- b. The Mayor and City Auditor are hereby authorized to make payment chargeable to the FY 2010-11 budget when demand is presented and approved by the proper authority.

SECTION 2. The Council declares that an emergency exists because delay would result in unnecessary prolongation of individuals' homelessness; therefore, this ordinance shall be in force and effect from and after its passage by Council.
