1) Legislation Title:

* Authorize an Intergovernmental Agreement with Multnomah County for the use of U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance FY 2011 Edward Byrne Memorial Justice Assistance Grant Program funds (Ordinance)

2) Purpose of the Proposed Legislation:

The City of Portland, the City of Gresham and Multnomah County are disparate jurisdictions. Portland will submit a joint application for the aggregate eligible allocation to all disparate municipalities. The joint application for the FY 2011 Justice Assistance Grant (JAG) Program must determine and specify the award distribution to each unit of local government and the purposes for which the funds will be used. Intergovernmental Agreements with the City of Gresham and Multnomah County must be completed, signed by the Authorized Representative for each participating jurisdiction and attached to the application, which will be submitted July 18, 2011.

The District Attorney's Office, the Department of Community Justice and the Sheriff's Office will use FY 2011 Bureau of Justice Assistance grant funds to fund County programs in accordance with the Bureau of Justice Assistance solicitation requirements. The agency budgets have not been submitted to the Police Bureau at the writing of this ordinance.

Application Review

The Portland Police Bureau posted a notice about the Edward Byrne Memorial Justice Assistance Grant (JAG) Program FY 2011 Local Solicitation and its proposed joint application on the City of Portland Police Bureau website <http://www.portlandonline.com/police/> on June 15, 2011. Visitors to the site were able to view a description of the grant program, a link to the Office of Justice Programs solicitations web page as well as the application.
