





Don't Let All This History Go to Waste

After their donation to the city in 1958, the Southern Pacific 4449, the Spokane, Portland & Seattle 700, and the Oregon Railway & Navigation 197 sat in the weather at Oaks Amusement Park for decades. Starting in 1980 each moved for restoration to the Brooklyn Roundhouse in southeast Portland. It took three decades and thousands

of volunteer hours for Portland to be the only city in the United States to own two operating steam locomotives, with the third currently under restoration. These links to the past have to vacate the Brooklyn Roundhouse by January 2012 to accommodate the expansion of the Union Pacific Railroad's intermodal facility.
