

## ORDINANCE No. 184785

\* Amend Intergovernmental Agreement with Multnomah County Department of County Human Services for continued support of outreach and permanent housing placement activities for people experiencing homelessness in East County. (Ordinance; amend Contract No. 30001793)

The City of Portland ordains:

### SECTION 1. The Council finds:

1. Through Ordinance No. 184220 the Council authorized an intergovernmental agreement (IGA) No. 30001739 between the Multnomah County Department of County Human Services (County) and the City of Portland Housing Bureau (City) to provide \$75,000 in County general funds for flexible outreach and housing placement to people experiencing homelessness in incorporated and unincorporated areas of Multnomah County east of the Portland city limits (East County) between July 1, 2010, and June 30, 2011.
2. The City subcontracted all work and funds associated with the IGA by amending an existing FY 2010-11 City Contract 32000362 between the City and JOIN. The County authorized the City to do so. All subcontracted work is complete and all funds have been spent.
3. The County has initiated an amendment (Exhibit A) to extend the existing IGA from July 1, 2011, through June 30, 2012, and to add \$75,000 in County general funds to continue the existing statement of work.
4. The above stated services meet the goals and objectives of the City.
5. The County has authorized the City to subcontract the work and funds associated with the amended IGA, and the City intends to subcontract all work and funds through a FY 2011-12 contract between the City and JOIN to be authorized through a separate Ordinance.

NOW, THEREFORE, the Council directs:

- a. The Bureau Director and the City Auditor are authorized to execute Amendment No. 1 to the Intergovernmental Agreement between the City and the County, attached as Exhibit A.
- b. The Mayor is hereby authorized to accept on behalf of the City payments of up to \$75,000 from the County as specified in the IGA.
- c. The Portland Housing Bureau is authorized to perform all administrative matters in relation to the IGA, requests for reimbursement from the County, and to submit required reporting on the Mayor's behalf.

SECTION 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the IGA; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.


