a) What impacts are anticipated in the community from this proposed Council item?

This action in itself has no impacts since it is not authorizing any expenditure. If, at a future date, City Council approves a redevelopment plan for the VMC, than construction jobs associated with the improvements will be generated.

Other likely public benefits would include:

- Upgrades to the Veterans memorial
- Improved spectator experience for sporting and cultural events
- Increased usage and amenities in both public spaces, exhibit halls and other areas of the facility
- Overall certainty concerning the long-term viability of the VMC which should leverage further investment in the Rose Quarter and the vicinity

b) Which community and business groups, under-represented groups, organizations, external government entities, and other interested parties were involved in this effort, and when and how were they involved?

- In August 2009, the Mayor established the Rose Quarter Stakeholder Advisory Committee (SAC). SAC members were chosen to represent a broad range of community interests including local advisory committees, sustainability, architectural preservation, urban planning and design, arts and entertainment, and inner eastside businesses among others.
- The SAC has held 16 public meetings from September 2009 to April 2011 where they discussed a variety of options for the VMC as well as design ideas for the overall Rose Quarter.
- The SAC is chaired by Mayor Sam Adams and has 31 voting members who represent the following organizations:

- A Memorial Coliseum Future Use Marketplace event was held in January 2010, which attracted more than 650 participants and included 33 concept slideshow presentations and information tables developed by the public.
- Two Veterans advisory group meetings were held where PDC received feedback on the future use of the VMC.
- A Draft Rose Quarter District Plan open house with the N/NE Quadrant Study (Nov. 2010) was held and over 127 people attended. This District Plan includes the VMC.
- A project website was developed (RoseQuarterDevelopment.org) and it has received more than 80,000 visits and logged hundreds of comments, questions, reuse ideas and blog entries.
- At the April 11, 2011 Oregon Convention Center Urban Renewal Advisory Committee (OCC URAC) meeting, the OCC URAC voted to submit a letter of support for the 19th Amendment.
- The Portland Development Commission approved the 19th Amendment at an advertised public hearing on May 11, 2011.
- The City Club hosted a forum on the Veterans Memorial Coliseum on July 29, 2011 (unassociated with this amendment).

c) How did public involvement shape the outcome of this Council item?

As part of the SAC process, an aspirational statement was presented to City Council on March 25, 2010.

We, the Rose Quarter Stakeholder Advisory Committee, support preservation of the Memorial Coliseum as an inspiring, community-focused, multi-purpose facility with improved flexibility to accommodate a multiplicity of events for public and private purposes, at a variety of scales and uses including, without limitation: sports, entertainment, arts and culture in a manner that honors Veterans, respects the cultural heritage of the African American neighborhood that was previously in this location, integrates education, showcases innovation in sustainability, and demonstrates a triple bottom line of social, environmental and economic equity in a way that is consistent with its status as a National Register historic property.

This Council action implements SAC and OCC URAC recommendations.

8. BACKGROUND/ANALYSIS

On August 10, 2011 Portland City Council will be asked to approve a formal amendment to the Oregon Convention Center Urban Renewal Area Plan (OCC URA). The essence of the amendment is to allow tax increment resources to be an eligible source of finances for capital improvements to the Veterans Memorial Coliseum (VMC). Any budget authorization related to the amount and purpose of the capital improvements will occur later in 2011 through a formal inter-governmental agreement which will require City Council action.

Also on August 10, City Council will receive a formal update on the Rose Quarter district planning effort as well as details related to the renovation of the VMC and the application of the housing set aside policy to the new financial capacity of the OCC URA.

Part of the progress report will include a discussion on PDC's recently released Request for Proposals for Architectural Design and Engineering services. The purpose of the solicitation and the contract (expected to be in the range of \$2,000,000) is to reach "high confidence" cost estimates for the renovation of the VMC. These estimates are necessary to inform City Council and other investment partners as part of the broader discussion of VMC improvements later this fall.

9. FINANCIAL IMPACT

There is no financial impact to the City through the passage of the 19th Amendment. The expenditures for the Architectural Design RFP are part of PDC's Adopted Budget and are not connected to the discussion of the housing set aside. The set aside application relates to new financial capacity.

10. RECOMMENDATION/ACTION REQUESTED

Approve the Resolution for the Nineteenth Amendment to the Oregon Convention Center Urban Renewal Plan.
