## ORDINANCE NO. 18480 6

Revise ordinance to update engineer estimate and construct the Carolina Pump Main Extension Project (Ordinance; amend Ordinance No. 183466)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Ordinance No. 183466 passed Council on January 13, 2010 authorizing a contract and providing payment for the Carolina Pump Main Extension Project (W01383). Due to budget constraints for the FY 2010-11 Budget, this project was placed on hold in October 2010.
- 2. The Water Bureau requests approval to construct the project to increase reliability and reduce the risk of pipeline failure.
- 3. The engineer's estimate for this project is \$1,900,000 with a High Confidence Rating. Funding is available in the Distribution Mains Program due to contract savings on the Westside Header Phase II project.

NOW, THEREFORE, the Council directs:

- a. Ordinance No. 183466 is amended to update the engineer's estimate to \$1,900,000 and construct the Carolina Pump Main Extension project.
- b. Upon the Council's acceptance of the Chief Procurement Officer's report recommending the lowest responsible bidder, the Chief Procurement Officer is authorized to negotiate and execute a contract for the project, provided the contract has been approved as to form by the City Attorney's office.
- c. All other terms and provisions of Ordinance No. 183466 remain the same and are not affected by this amendment.
