#### RECOMMENDATION T.

Approve amendment to increase the not to exceed limit on the contract with CMTS to allow continued services through the start up and close out of the CSO Program.

#### II. **BACKGROUND**

Contract 37903 was authorized by Council April 4, 2008 with an initial term through December 31, 2010. The established not to exceed limit was \$12,250,000. The Ordinance authorized the Purchasing Agent to execute an amendment extending the Contract if needed through December 31, 2012 and increasing it by \$4,750,000 to total of \$17,000,000. In January 2011 Council authorized an amendment to add an Inspector Apprentice Program and increased the contract \$300,000 to cover the cost of apprentices.

From April 2008 through July 2011 BES had Capital Improvement Program expenditures of over \$550 million and completed construction of 180 projects. In addition to the 180 completed projects, there are currently 142 projects in the construction phase. CMTS has provided construction management, inspection and project support personnel during this period to augment BES staff. In addition to planned projects, the CIP included a number of unanticipated or emergency projects that required inspection and construction management services beyond what was anticipated when the original contract estimate was prepared in late 2007. These include:

- Fanno Basin projects
- Transit Mall Rehab
- NW 23<sup>rd</sup>
- Eastside Streetcar
- Couch Couplet

- Sandy Blvd.
- Iowa Viaduct

This requested increase is necessary to provide continuing services for projects currently under construction and CSO start up and close out activities through the end of the contract term in late 2012.

Contract employees provided through this contract supplement the City work force during peak periods, providing construction managers, inspectors and project support personnel. Bureau staff routinely monitor the use of these services in efforts to balance an appropriate mix of contract and city staff. The "BES Guidelines for Staffing Decisions" are reviewed periodically to ensure we are applying a consistent approach in how we utilize contract staff. And, during the annual budget process, the overall mix is reviewed and as necessary new City positions proposed.

#### III. FINANCIAL IMPACT

Services obtained and billed through these contracts are included in the adopted Capital Improvement Program budget.

None identified. The contracts meet all City requirements for contracted services.
