BACKGROUND/ANALYSIS

The Portland Bureau of Parks and Recreation requested a review of a Property Acquisition Manager position. The Bureau of Human Resources (BHR) reviewed the request and determined a new classification specification needed to be created to reflect the increased level of responsibility for business and strategic partnership development. BHR created a unique classification of Parks Property and Business Development Manager for this single-incumbent position. BHR is recommending a Nonrepresented salary range 10 for this new classification.

8. FINANCIAL IMPACT

There is no increased cost in salary and benefits for this classification action. However, when the current position is reclassified, the new classification will be at a higher salary level. Currently the annual maximum rate for the position is \$84,635. The classification approved by this ordinance will have a maximum rate of \$93,829, an annual increase of \$9,194.
