RECOMMENDATION

- * Authorize the Director of the Bureau of Environmental Services, in consultation with the Mayor and the Commissioner in Charge of the Office of Healthy Rivers, to enter into the Portland Harbor Natural Resource Damage Allocation Participation Agreement (NRD Agreement). (Ordinance)
- BACKGROUND: The non-judicial allocation process for determination of liability for natural resource damages in Portland Harbor will take place over approximately the next four years. It is important to participate in the process while concurrently working with the Trustees to identify and implement restoration projects.
- FINANCIAL IMPACT: The cost of participation is estimated not to exceed 3. \$50,000/year for approximately four years. Funding will come from the Portland Harbor budget.
