

AMENDMENT NO. 13
AGREEMENT FOR PORTLAND STREETCAR OPERATIONS
ASSISTANCE SERVICES

This Amendment No. 13 is to the Agreement between the City of Portland (City) and Portland Streetcar, Inc. (PSI) for Portland Streetcar Operations Assistance dated January 12, 2001, City Agreement No. 33325 (City/PSI Agreement No. 33325)

RECITALS

Whereas, under City/PSI Agreement No. 33325 as amended PSI subcontracts for personnel to support Portland Streetcar Operations including the services of a Streetcar Parts/Acquisition Specialist assigned to work at the Streetcar Maintenance Facility under the supervision of the Streetcar Office Manager; and

Whereas, PSI provides the services of the Streetcar Parts/Acquisition Specialists through a subcontract with Shiels Obletz Johnsen, Inc. (SOJ); and

Whereas, in late 2010 the Streetcar Parts/Acquisition Specialist employed by SOJ resigned; and

Whereas, after conducting a selection process that included advertising in local newspapers and online, reviewing 35 applications and interviewing 5 applicants, a qualified replacement was recommended by a selection committee consisting of the Streetcar Maintenance and Assistance Maintenance Managers, both City employees, and the Streetcar Chief Operating Officer and Office Manager, both SOJ employees; and

Whereas, the recommended applicant was hired by SOJ despite his request for higher wages than those paid the previous employee and which exceeds the maximum compensation provided for in Amendment No. 12 to City/PSI Agreement No. 33325 by an estimated \$36,000 including salary, taxes, benefits and other related expenses in FY 11-12 through 6/30/12, the period covered by Amendment No. 12; and

Whereas, the additional cost for these services are included in the proposed FY 11-12 City Budget for Portland Streetcar Operations.

AGREEMENT

1. Scope of Services. PSI, through its subcontract with SOJ, shall continue providing the services of the Streetcar Parts/Acquisition Specialist.
2. Maximum Compensation. The total Maximum Compensation provided for in Amendment No. 13 to the City/PSI Agreement No. 33325 shall be increased by \$36,000 from \$393,000 to \$429,000.
3. ALL OTHER TERMS AND CONDITIONS OF THE CITY/PSI CONTRACT #33325 AS AMENDED REMAIN UNCHANGED.
