ORDINANCE No. 184928

*Pay claim of Catherine Schutz involving Portland Fire Bureau. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Catherine Schutz has filed a property damage claim against the City for damages suffered in a motor vehicle accident involving the Portland Fire Bureau on August 27, 2011.
2. The claim has been investigated by Risk Management Services. The investigation indicates there is risk the City may be found liable. Therefore, in order to avoid the risk of an adverse jury award, we feel it is prudent to compromise the claim at this time.
3. Risk Management Services recommends the claim be compromised for the total sum of \$12,750, subject to the claimant providing the City with a release in a form to be approved by the City Attorney. Risk Management has previously advanced \$5,000 to Ms. Schutz on this claim; approval of this Ordinance will allow payment of the \$7,750 balance owed.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver a check in the amount of \$7,750 made payable to Catherine Schutz.
- b. Risk Management Services will execute a payment authorization in the amount set forth in sub-paragraph (a) above.


