**2) Purpose of the Proposed Legislation:**

To accept additional grant funding from the Oregon Department of Transportation (ODOT), Transportation Safety Division for the Multnomah County DUII Intensive Supervision Program in the amount of \$1,410. The original award was \$70,000. The grant period remains October 1, 2010, through September 30, 2011.

**FINANCIAL IMPACT****4) Revenue: Will this legislation generate or reduce current or future revenue coming to the City? If so, by how much? If so, please identify the source.**

The Oregon Department of Transportation will reimburse the City a maximum of \$71,410 for expenses incurred by the bureau for Traffic Division personnel overtime hours worked. The Traffic Division officers will provide direct law enforcement capability to the court-based probation program by conducting warrant sweeps.

The City will incur payroll expenses above the grant's \$60.48 per hour reimbursement rate (average of Traffic officer and sergeant overtime rates) and all benefit expenses related to Traffic sworn personnel overtime. Additional local match of \$4,230 shall be provided by funds from City of Portland matching funds in the form of sworn personnel straight time expenses in the FY 2011-12 budget of the Police Bureau. The total local match amount for FY 2010-11 and FY 2011-12 will be \$214,230.
