

ORDINANCE No. 185057

Extend term of a franchise granted to WCI Cable to build and operate telecommunication facilities within City streets (Ordinance; amend Ordinance No. 172750)

The City of Portland ordains:

Section 1. The Council finds:

1. On September 30, 1998, the Council granted a franchise to WCI Cable to build and operate telecommunications facilities within the City's streets. Ordinance No. 172750.
2. The Council previously extended the term of WCI Cable's telecommunications franchise ordinance until December 31, 2011. Ordinance No. 183368.
3. On October 26, 2011, the City Council adopted non-emergency Ordinance No. 184957, amending Title 17 of the Portland City Code. Among other matters, the ordinance updated, clarified and reorganized various code sections. The Bureau of Transportation will need to adopt administrative regulations implementing various aspects of the revised code provisions. This process will affect some of the standard franchise language. As the bureau works to complete this process, the Office for Community Technology is recommending that the City Council extend existing franchises.

NOW, THEREFORE, the Council directs:

- a. Ordinance No. 172750 is hereby amended to extend the term of the permit, continuously and without interruption, through December 31, 2012.
- b. All other terms and conditions of the Ordinance No. 172750 shall remain the same, and the terms and conditions of the Agreement shall remain unaltered.
- c. On or before the thirtieth (30th) day after this ordinance becomes effective, WCI Cable shall file in the Office of the Auditor of the City of Portland a written acceptance of this Ordinance, executed by WCI Cable, meeting the approval of the City Attorney. Any failure on the part of WCI Cable to file such written acceptance within such time shall be deemed an abandonment and rejection of this Ordinance, and this Ordinance shall thereupon be null and void. Such acceptance shall be unqualified and shall be construed to be an acceptance of all the terms contained in this ordinance.
