Re: FY 2012-13 Portland Housing Bureau Budget Process

Dear Contractor,

You are a valued partner, and we cannot meet our mission without you. We are writing to let you know that this year's budget process is underway. Throughout this year's budget process we want to keep you updated and informed of important dates, the budget outlook and how you can give feedback and input.

Budget Outlook

The Portland Housing Bureau's budget resources are subject to sizable reductions. Based on the Transportation, Housing and Urban Development appropriations bill for the current fiscal year, signed by President Obama last month, Portland will see a 14% or \$1.3 million cut in CDBG and a 37% or \$1.5 million cut in HOME. Locally, the Portland City Council has directed us to submit three budget scenarios, showing 4%, 6%, and 8% reduction in ongoing General Fund, or \$250,000 - \$500,000 in cuts. Additionally, we rely on \$4.8 million in one-time General Fund to support our safety net and access services. Because of issues of property and business tax forecasts, these funds are also at risk. PHB is allowed to submit a request for continued funding for programs that have been supported by these "One-Time Only" dollars, but at this time it is not clear how much will be funded.

These cuts will affect FY 12-13 contract amounts as well as funds available next year for affordable housing development. Commissioner Fish, PHB's Director and staff, and the Portland Housing Advisory Commission (PHAC) want your feedback as we make decisions.

From now until our budget is submitted to OMF, we are asking program managers to convene contractors by program area to discuss strategies to apply cuts. Expect to hear from Contract Managers by the end of the year. We are also meeting with PHAC members and encourage you to attend the PHAC meeting to provide comment. Decisions will be guided by these discussions, our Strategic Plan investment priorities, and the eligible uses of our funding sources. Following the City

We value your opinion and I hope you will participate in our decision making process. This includes getting your best thinking about how you might structure potential cuts given your current contract with the bureau. But importantly, we also want to use your feedback to help us tell the story of the impact of the cuts to our collective work. The work you do is vital to our community and we will advocate to find a means to continue that work.
