WHEREAS, Resolution 36859 directs the Chief of Police to provide a report with appropriate public information to the City Council and public by the end of January each year on the Portland Police Bureau's work with the Federal Bureau of Investigation's Joint Terrorism Task Force, including any issues related to compliance with Oregon laws.



NOW, THEREFORE, BE IT RESOLVED, That the deadline for the current Portland Police Chief's first public report on the Portland Police Bureau's work with the Federal Bureau of Investigation's Joint Terrorism Task Force be extended to the end of February, 2012.


