As part of a broad public involvement approach in this phase of the West Hayden Island project, an Advisory Committee continues to advise the City with the implementation of Council Resolution No 36805 and the various requested studies related to decisions on the future of West Hayden Island. This ordinance is to amend the funding and time period of the contract with a project facilitator, who is charged with facilitating the Project Advisory Committee.

b) Which community and business groups, under-represented groups, organizations, external government entities, and other interested parties were involved in this effort, and when and how were they involved?

As part of the City's broader Public Involvement Plan an Advisory Committee was formed for West Hayden Island. The Advisory Committee is made up of 12 members with representation from the following groups/organizations: Oregon Fish and Wildlife, Port of Portland, Metro, Hayden Island Neighborhood groups (2 representatives), Oregon Association of Minority Contractors, Planning and Sustainability Commission, Audubon Society, Lower Columbia River Estuary Partnership, Portland Parks and Recreation, NW Oregon Labor Council and Capacity Commercial Group. The public involvement plan also includes the formation of technical panels for the review of studies that are being done per Council Resolution No. 3680. Several State and Federal regulatory agencies have been, and will continue to be involved as part of the technical review panels. This amendment adds funding and extends the period of the contract to enable the project facilitator, who is charged with facilitating Advisory Committee meetings, subcommittee meetings and technical panel discussions, to conduct a successful and transparent process.

c) How did public involvement shape the outcome of this Council item?

This Council item requests authorization of a third amendment to the contract with the Institute of Conflict Management, Inc. to provide additional funding and extend facilitation support service for the West Hayden Island Plan. The project Advisory Committee, as well as all individuals who have been involved with the project facilitator, continue to support his work to date on all project activities.
