a) What impacts are anticipated in the community from this proposed Council item?

Improvements will be made to the secondary system at the Columbia Blvd Wastewater Treatment Plant (CBWTP). As a result of this project, there will be an increase to the amount of construction vehicles and equipment that use N Columbia Blvd. The construction will take place on the treatment plant property, primarily during daytime hours. Typical construction impacts such as noise, vibration, traffic delays, etc. are not anticipated to affect the general public.

b) Which community and business groups, under-represented groups, organizations, external government entities, and other interested parties were involved in this effort, and when and how were they involved?

This project was identified in the latest CBWTP Facilities Plan (March 2010) and the master plan update. During the master plan update, numerous stakeholders were engaged including the Columbia Slough Watershed Council, Kenton, Portsmouth, and St Johns neighborhood associations, Columbia Corridor Association, NAYA, and N Portland Business Association. Staff attended regular meetings of the stakeholder groups listed as well as conducted direct outreach to engage interested parties in the development of the master plan update. The CBWTP Citizens Advisory Committee was also instrumental in sharing information about the update with stakeholders.

c) How did public involvement shape the outcome of this Council item?

Public feedback helped the treatment plant identify areas of operation at the plant that were challenging or problematic to the general public. Odor originating at the treatment plant and moving into area residential areas was one particular problem that the stakeholders identified during the master plan update. A number of plant improvements were undertaken to address odor at the treatment plant as a result of public involvement. This project will not increase the level of odor at the treatment plant or in nearby neighborhoods.

I. RECOMMENDATION

Authorize a contract and provide payment for construction of the Secondary Process Improvements at the Columbia Boulevard Wastewater Treatment Plant, Project No. E08909 (Ordinance)

II. **BACKGROUND**

The secondary treatment system at the Columbia Boulevard Wastewater Treatment Plant provides biological treatment for the wastewater through the plant. The current plant discharge permit requires minimum secondary biological treatment of 100 million gallons per day (mgd). In 2014, this minimum requirement will be increased to 110 mgd. Improvements to the secondary treatment system are needed to increase capacity to meet new permit requirements.

The new discharge permit also requires new wet weather flow treatment mode (step feed) be incorporated into the secondary treatment system, through the Mutual Agreement and Order (MAO), as part of the new discharge permit.

The last major improvements to the secondary treatment system were completed in 1994. Improvements are needed to update, and automate, the monitoring and control systems to handle rapid flow changes from the recently completed East Side Combined Sewer Overflow program.

III. FINANCIAL IMPACT

The construction cost estimate is \$9,100,000. The level of confidence in the cost estimate is optimal. The project is included in the adopted BES CIP budget.

The project is consistent with City policy to contain and maximize treatment.

VII. CITIZEN PARTICIPATION

The local community citizens participated in the project through the CBWTP Citizen Advisory Committee (CAC). BES staff meets with the CAC regularly to update on projects at the plant and to receive feedback.
