

ORDINANCE No. 185131

Authorize a contract and provide for payment for the construction of the SE 2nd and 3rd Ave Sewer Replacement and SE 3rd and Alder Rehabilitation Project No. E08847 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. There are numerous cracks, broken joints, sags and partial collapse in the 10" sewer line on SE 2nd Ave and the 8" sewer line on SE 3rd Ave. that warrants immediate repair. Also, the intersection of SE 3rd and Alder needs to be rehabilitated after the completion of the construction work for the East Side CSO project.
2. The Bureau of Environmental Services has prepared plans and specifications for replacing the existing sewer main, service laterals, manholes and rehabilitation of the intersection.
3. The Bureau of Environmental Services requires the furnishing of materials and labor for this project.
4. The established cost is \$900,000. The level of confidence for this project is optimal. Funds are available in the Sewer System Operating Fund, FY 2011-2012 Budget, Bureau of Environmental Services, Cost Center, WBS Element E08847.C60.

NOW, THEREFORE, the council directs:

- a. The Commissioner of Public Affairs is authorized to execute a contract with the apparent lowest responsible bidder for the purpose described in Section 1, in the amount of \$900,000.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.


