

ORDINANCE NO. 185139

*Authorize settlement agreement with David Doran regarding wage claims (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. David Doran was the former caretaker of Pittock Mansion and lived in the apartment on the mansion grounds rent free in exchange for performing certain duties.
2. After the City of Portland terminated the relationship in September 2010, Mr. Doran filed a wage claim with the State of Oregon Bureau of Labor and Industries.
3. The City disputed Mr. Doran's wage claim because Mr. Doran was not an "employee."
4. As part of the proposed settlement, the City will pay Mr. Doran \$15,000.
5. Also, as part of the proposed settlement, Mr. Doran will release all wage claims under state and federal law.
6. Portland Parks & Recreation and the City Attorney's Office recommend acceptance of the proposed settlement.


NOW, THEREFORE, the Council directs:

- a. The Parks Director or his designee is authorized to negotiate all documents to settle Mr. Doran's wage claim, including a settlement agreement in substantially the same form as the agreement attached as Exhibit A.
- b. After the effective date of the settlement agreement, Portland Parks & Recreation is authorized pay Mr. Doran \$15,000.00.

Section 2. The Council declares that an emergency exists to avoid undue and costly delay in settling this claim; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
