### 7. BACKGROUND/ANALYSIS:

Due to the advanced age and increasing maintenance and repair costs associated with the two current in-service fireboats in Portland Fire & Rescue's fleet (the 27 year old *Williams* and the 15 year old *Buss*), funds granted via the General Obligation Bond approved by the City's voters will be used to replace these aging assets with two new fireboats. The Chief Procurement Officer has advertised and received Offers under Request for Proposals (RFP) 113535, for the construction of two 50' aluminum fireboats and three proposals were received. The proposals were reviewed, evaluated and scored in accordance with Portland City Code 5.33. Oregon Iron Works, Inc. was identified as the most qualified respondent and received the highest evaluation score from an independent evaluation committee. The City issued a Notice of Intent to Negotiate and Award a Contract to Oregon Iron Works, Inc. on January 23, 2012.

The timeline for final delivery is anticipated to take place sometime in the year 2014. These fireboats will be equipped with the latest technology in propulsion, navigation, safety and firefighting equipment to effectively and efficiently serve the City for many years to come.

### 8. FINANCIAL IMPACT:

General Obligation Bond funds authorized by the citizens of Portland in the November 2010 election will be used to pay for the purchase of the two fireboats.

Authorize a Contract with Oregon Iron Works, Inc., to provide two 50' aluminum hull fireboats for a contractual total not to exceed \$5,013,277.
