## ORDINANCE No. 185150

\*Authorize a contract with Arthur J. Gallagher Risk Management Services, Inc. for Insurance Broker Services for a total not-to-exceed amount of \$311,644. (Ordinance: Contract No. 30002520)

The City of Portland ordains:

## Section 1. The Council finds:

- 1. The City of Portland requires Insurance Broker Services to maintain appropriate types and limits of City insurance requirements and to mitigate risk and potential loss exposure.
- 2. The services were advertised under Request for Proposals BRM006 and Six (6) responsive proposals were received. The selection committee reviewed and scored these proposals in accordance with PCC 5.68 and selected the highest scored Proposer, Arthur J. Gallagher Risk Management Services, Inc.
- 3. The City desires to enter into a PTE contract with Arthur J. Gallagher Risk Management Services, Inc. with a not-to-exceed contract amount of \$311,644.
- 4. The M/W/ESB participation in this contract is 0%.
- 5. Sufficient funding resides in Operation Fund 52100.

## NOW THEREFORE, the Council Directs:

- a. The Chief Procurement Officer is authorized to enter into a contract with Arthur J. Gallagher Risk Management Services, Inc. for services in accordance with contract 30002520, hereto attached as Exhibit A.
- b. The Mayor and the Auditor are hereby authorized to draw and deliver checks payable to Arthur J. Gallagher Risk Management Services, Inc. chargeable to the Bureau of Risk Management when demand is presented and approved by the proper authorities.

Section 2. The Council declares that an emergency exists because the City would be at significant risk without continuous representation. Therefore, this Ordinance shall be in full force and effect from and after its passage by Council.
