

ORDINANCE No. 185168

\*Authorize a contract to purchase one full sized SUV for \$40,000 funded by Trimet (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The CityFleet Division of the Bureau of Internal Business Services recognizes the need for one additional full sized SUV to be used by Portland Transit Police K-9 drug sniffing unit for added security on the transit lines.
2. It has been determined that one full sized SUV needs to be acquired for Portland Transit Police – vehicle #N12017, Exhibit A attached.
3. The estimated cost of these vehicles is \$40,000.00 for one full sized SUV funded by Trimet.
4. The City now desires to acquire this vehicle.

NOW, THEREFORE, the Council directs:

- a. The CityFleet Division of the Bureau of Internal Business Services, OMF, is hereby authorized to acquire this vehicle for use by the Portland Transit Police per the listed request identified in the attached, Exhibit A.
- b. The Mayor and City Auditor are hereby authorized to pay for said purchases from the CityFleet replacement funds.

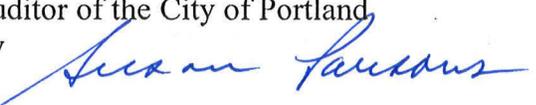

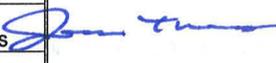
