*Authorize a contract with Hoyt Arboretum Friends Foundation to define purposes, responsibilities and accountability as to Hoyt Arboretum (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Hoyt Arboretum is a 183 acre public park located in Southwest Portland, owned and managed by Portland Parks & Recreation (PP&R) for the public's education and enjoyment.
- 2. The Hoyt Arboretum Friends Foundation (HAF) is a non-profit corporation formed in 1986 and formally recognized by Resolution 34188 on October 15, 1986. The purpose of HAF is to support and enhance Hoyt Arboretum facilities, collections, and educational programs.
- 3. Since 1996, the HAF has provided educational programs, special events, and capital improvements for Hoyt Arboretum by and through agreements with Portland Parks & Recreation.
- 4. The purpose of the new Agreement is to define the relationship between PP&R and HAF in regard to their respective purposes, responsibilities, and accountability as to Hoyt Arboretum.

NOW, THEREFORE, The Council directs that:

- The Director of Portland Parks & Recreation is authorized to execute the a. Agreement between the City and HAF in a form substantially similar to the attached agreement and as approved as to form by the City Attorney.
- b. The Director and the Auditor are authorized to provide payment chargeable to the applicable budgets when demand is presented and approved by the appropriate authorities.

Section 2. The Council declares that an emergency exists because the previous agreement has expired and a delay may deprive the public of the benefits of the new agreement; therefore, this ordinance shall be in full force and effect after its passage by Council.
