The project consists of two separate locations. The Portsmouth Force Main Odor Control Ventilation Facility (POVE) is located outside of the Columbia Blvd Wastewater Treatment Plant between N. Columbia Blvd and N. Columbia Ct. and the Portsmouth Shaft Improvements (POSH) is located on N. Willamette Blvd off Carey Blvd at the current North Shaft Site for the Portsmouth Force Main. There will be construction noise and some traffic delays for truck traffic at both locations and some minor access issues to the business adjacent to the POSH location.

b) Which community and business groups, under-represented groups, organizations, external government entities, and other interested parties were involved in this effort, and when and how were they involved?

The construction contracting community, including contractors certified with the State of Oregon as minority, women, and emerging small businesses. They became involved when the project advertised for bids on January 4, 2012.

- 7. **BACKGROUND/ANALYSIS:** Ordinance Number 185116 adopted on January 25, 2012 authorized a contract and provided for payment for the Portsmouth Force Main Odor Control Project. The purpose of this project is to provide for the installation of ventilation and odor control facilities in the existing Portsmouth Tunnel system to prevent the release of odors, in particular at the North shaft site where the new Portsmouth Force Main will discharge into the Portsmouth tunnel.
- 8. <u>FINANCIAL IMPACT:</u> The engineer's estimate for this project was \$1,800,000.00 and the confidence level was optimal. Funds are available in the Sewer System Operating Fund, FY 2012 Budget, Bureau of Environmental Services, WBS Element E08927.
- 9. RECOMMENDATION/ACTION REQUESTED: Accept recommendation to award the contract to Triad Mechanical, Inc. in the amount of \$1,463,103.00.
- 10. SCOPE OF WORK ON PROJECT: The project includes all labor, materials, tools, equipment, and supervision necessary to construct the Portsmouth Force Main Odor Control Project. The Portsmouth Force Main Odor Control Project includes work at two sites. The Portsmouth Shaft (POSH) Radio and Instrumentation Building located at 6825 N Willamette Boulevard and the Portsmouth Ventilation Facility (POVE) at

5050 N Columbia Court, the intersection of North Hodge Avenue and North Columbia Boulevard.
