HEARINGS OFFICER'S FINAL ORDER

CITY OF PORTLAND, petitioner, vs. SERAFORM LLC, respondent

CASE NO. 2110003 [Bureau Case No. 11-113748 DB]

FINDINGS OF FACT AND CONCLUSIONS OF LAW:

On January 17, 2012, the Hearings Officer received a memo from Curt French (Exhibit 30) requesting that the hearing scheduled for January 18, 2012, be cancelled. Mr. French stated in Exhibit 30 that "the City considers the respondent to be in substantial compliance with the requirements of the complaint. The additional civil penalty of \$37,000.00 is not requested by the City." The Hearings Officer admits, into the evidentiary record, Exhibits 27 through and including 30.

The Hearings Officer granted the request made by Mr. French in Exhibit 30 and cancelled the hearing scheduled for January 18, 2012. The Hearings Officer also waived the \$37,000.00 civil penalty at the request of Mr. French.

The Hearings Officer finds that, until this file is closed, the Respondent remains responsible for the correction of the violation set forth in Exhibit 1a and is responsible to pay the civil penalty assessed in the Hearings Officer's Second Interim Order (\$1,741.80 plus any City processing fees). The Hearings Officer finds it reasonable and appropriate to retain jurisdiction for an additional thirty (30) days at which time, unless an additional hearing is requested by the City or Respondent, the case shall be closed.

ORDER AND DETERMINATION:

- 1. Respondent shall correct the violation set forth in Exhibit 1a.
- 2. Respondent shall remain liable, until paid in full, for the civil penalty assessed by the Hearings Officer in the Hearings Officer's Second Interim Order (\$1,741.80 + any processing fees).
- 3. The Hearings Officer retains jurisdiction over this case until May 1, 2012, at which time the Hearings Office case shall be closed.
- 4. This Final Order has been mailed to the parties on March 26, 2012, and shall become final and effective on April 9, 2012. Any objections to this Final Order must be in writing and received by the Code Hearings Office prior to the effective date.
- 5. This Final Order may be appealed to a court of competent jurisdiction pursuant to ORS 34.010 et seq.
