#### a) What impacts are anticipated in the community from this proposed Council item?

Once BES's Revegetation staff has conducted major restoration work on River View, Portland Parks and Recreation will conduct outreach to local non-profit organizations and the general public for incorporating stewardship activities onsite, such as monitoring invasive and native plants, installing natives, and erosion control.

# b) Which community and business groups, under-represented groups, organizations, external government entities, and other interested parties were involved in this effort, and when and how were they involved?

Representatives from West Multnomah Soil and Water Conservation District, Collins View Neighborhood Association, Trust for Public Land, and Friends of Tryon Creek State Natural Area all expressed support for this acquisition and subsequent restoration at the City Council hearing when the City's intent to acquire the acquisition was announced (May 5, 2011).

#### c) How did public involvement shape the outcome of this Council item?

The stakeholders noted above recognize the critical need for restoration on River View Natural Area to protect watershed health, and have expressed interest in creating partnerships to ensure a successful restoration effort.

#### d) Who designed and implemented the public involvement related to this Council item?

Portland Parks and Recreation, in concert with BES, has developed an initial communications plan for phase one of the stabilization and restoration plan, which defines which stakeholders who receive outreach about stabilization efforts on the site (including revegetation and restoration), as well as the form of communication that will take place for each.

#### I. RECOMMENDATION

City Council should pass this ordinance to authorize this grant application to OWEB for restoration of 146 acres of high-priority natural area in the Willamette Watershed. Approving submittal of this grant application will allow BES to seek funding that will leverage BES's Grey to Green budget for restoration of sensitive natural areas and PP&R's Sellwood Bridge (4f) mitigation funds.

#### II. BACKGROUND

In November of 2007, the Grey to Green Initiative was launched to accelerate principal elements of the Portland Watershed Management Plan's implementation. Council passed Resolution 36599 on April 16, 2008 to establish the Grey to Green Initiative. Activities benefiting from Grey to Green include ecoroofs, green streets, trees, revegetation, invasive species control, culvert replacement, and acquisition of sensitive lands. Most pertinent to this proposal is the goal to control invasive species on 800 acres.

The City of Portland (BES and PP&R), in collaboration with Metro and the Trust for Public Land, recently acquired 146 acres of the River View Cemetery, a high-priority natural area in the Willamette Watershed. Protection of this natural area will help BES to meet its goal of protecting sensitive natural areas.

Invasive plants are prevalent throughout the area. Without treatment, invasive vegetation will cause irreversible damage to the site's forest canopy and wildlife. The City's Watershed Revegetation staff developed a restoration plan to remove and control ivy, clematis, blackberry and nuisance trees such as holly, laurel and hawthorn.
