

ORDINANCE No. 185272

*Amend contract with Portland Patrol, Inc. to increase security coverage in SmartPark Garages, extend the term, and provide for payment. (Ordinance; amend Contract No. 30002191)

The City of Portland ordains:

Section 1. The Council finds:

1. The City entered into a contract with Portland Patrol, Inc. in July of 2011 to provide security services through June 30, 2012 in the six (6) City-owned SmartPark garages. The contract is written to allow an additional four (4) year extension by mutual consent.
2. The amount of the contract, as bid through the City's Bureau of Purchases, is currently \$460,800.00 per year.
3. An increased level of security services is now needed at all SmartPark garages due to increased customer activity in downtown and to ensure sufficient 24-hour coverage.
4. This contract is being amended by \$75,000, bringing the total annual amount in Fiscal Year 2011/2012 to \$535,800.
5. This contract is being amended by \$175,000 annually beginning in Fiscal Year 2012-2013, bringing the total annual amount not to exceed contract value to \$635,800, or \$2,543,200 for the extended term of the contract.
6. This contract is being amended to extend the term of the contract through June 30, 2016.

NOW THEREFORE, the Council directs:

- a. The Chief Procurement Officer of the City of Portland is authorized to execute the amendment, substantially in accordance with the document attached hereto, to Contract No. 30002191 with Portland Patrol, Inc.
- b. The Mayor and the Auditor are hereby authorized to draw and deliver checks payable to Portland Patrol, Inc., chargeable to the City's Parking Facilities Fund 606000.

Section 2. The Council declares an emergency exists because increased security services at SmartPark garages are needed immediately and sufficient funds to pay for said services must be approved by Council; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
