Authorize a contract with Elcon Associates, Inc. for design services for the Groundwater Electrical Supply Improvements Project (Ordinance)

2) Purpose of the Proposed Legislation: The purpose is to authorize a contract with Elcon Associates, Inc. for the design of the Groundwater Electrical Supply Improvements project.

This project will design a second main transformer at the Groundwater Pump Station to be installed in parallel with the existing transformer. The work will also include preparing specifications for a replacement for an existing Air Circuit Breaker (ACB). A failure of either the transformer or the ACB would prevent operation of the booster pumps, and no groundwater could be supplied to the potable water distribution system. These improvements are needed to advance the reliability of the Groundwater supply system.
