9) If "YES," please answer the following questions:

a) What impacts are anticipated in the community from this proposed Council item? CWSP grants support community-requested watershed stewardship activities. The community will be positively impacted by this item in part because the activity and project ideas come from, and are desired by, the community. Along with stormwater management results which provide direct environmental benefits and cost savings, projects also build skills, educate citizens, and beautify neighborhoods. Direct watershed health benefits include removal of invasive plants, habitat restoration, erosion control, tree planting and protection, removal of impervious surfaces, soil improvements which reduce stormwater runoff, and planting native vegetation. These grants also strengthen community ties through cooperative programs and volunteer participation which draw diverse groups together for joint activities and common goals.

Impacts include at-risk youth and other students gaining skills, knowledge and experience in construction and/or environmental careers. (Groundwork Portland Green Teams, POIC's project at Columbia Children's Arboretum, Tryon Creek Mentor Program provide these added benefits.) Several neighborhoods will have improved park and natural areas as restoration projects are completed. Landowners in Tryon Creek watershed will receive support as they undertake habitat improvement projects. Other neighborhoods will be enhanced by rain gardens, bioswales and planters added to schools, churches and commercial areas which are visible to or accessible by the entire community. For example, the labyrinth and rain garden at Pilgrim Lutheran Church will be open to the public and provide illustration for the naturescaping and rain garden workshops hosted in their building. The Nature Trail at Franklin High School enhances a walkway already in public use. Both of these grantees report that other garden and stormwater projects already completed at these sites have reduced criminal and undesirable activities on their property. Asphalt or concrete removal is an important element in the plans for Word & Spirit Church, Beach School and Pilgrim Lutheran Church; along with environmental benefits, grantees are looking forward to more beautiful and functional parking lots and playgrounds. Projects at Tabor Commons, PCC and Franciscan Montessori School, along with many others, include interpretive materials to educate the public about the value of stormwater and watershed restoration. Many projects also bring together community members in new cooperative activities. At Pilgrim Lutheran, English-speaking and Spanishspeaking congregations are working on their project together; Franciscan Montessori School's program involves children in the low income housing complex in the next block as well as those enrolled. Franklin High School's project includes elements to bridge divisions within the school community. Mini-grants for native plants support older projects when initial plantings fail or are damaged or expansion opportunities exist.

b) Which community and business groups, under-represented groups, organizations, external government entities, and other interested parties were involved in this effort, and when and how were they involved?

Outreach about the grant was provided as follows:

CWSP used direct telephone outreach and attendance at public events to promote the grants program this year. CWSP also provided extensive technical assistance to community groups that were interested in applying for grants and developing stewardship projects.

CWSP graduate students held three grant workshops to help prospective applicants write their proposals, at Central Library, Kenton Library, and East Portland Community Center.

Additionally, students attended East Portland Sunday Parkways and East Portland Expo, participated in a neighborhood bike ride with Powellhurst Gilbert NA and met with neighborhood coalition staff from SE Uplift and EPNO to learn about emerging stewardship organizations in their service areas.


Direct support to interested groups was provided direct telephone outreach to over 30 organizations. Additional assistance or advice was provided to over 50 organizations. CWSP staff held meetings, on site consultations, and arranged technical assistance for 19 organizations out of the 50.

I. RECOMMENDATION

Authorize grant agreements and intergovernmental agreements with eleven nonprofit and public entities related to the Community Watershed Stewardship Program. (Ordinance)

II. BACKGROUND

Local organizations have been participating in the city's Community Watershed Stewardship Program since its start in 1995. To date, CWSP has granted \$876,000 to 198 projects. As of mid 2011, these funds were matched by \$3.3 million in community support through donations of services, materials and volunteer time. Over 41,000 people have donated 325,000 volunteer hours, planted 135,000 native plants and trees, restored over 64 acres of riparian and upland habitat, and enhanced over 52,000 linear feet of streams Community Watershed Stewardship projects can be found along streams and sidewalks, in parks, schoolyards, church parking lots, below downspouts and up on roofs.

The primary elements of the program are education, watershed improvements, evaluation and documentation of progress, school curriculum based watershed involvement, and technical/financial support to citizens. This year's projects include: Portland Opportunities Industrialization Center Engaging At-Risk Youth (\$9,819), PCC Sylvania Habitat Restoration Team Natural Area Park Restoration and Education (\$6,700), Friends of Tryon Creek Watershed Restoration Mentor Program (\$10,000), Pilgrim Lutheran Church Rain Garden (\$6,500), Gilbert Park School Outdoor Learning Area (\$10,000), Franciscan Montessori Earth School Windows into Wetlands (\$3,900), Groundwork Portland Green Teams (\$8,000), Franklin Gardens Nature Trail (\$7,450), Tabor Commons Sustainable Stormwater Display Shelter (\$8,100), Beach School Stormwater Gardens (\$8,160) and Depave Word & Spirit Church Parking Lot Greening (\$10,000). Additional community projects will be award mini-grants not exceeding \$500 each for the purchase of native plants for stormwater and natural area restoration projects (\$6,871).

\$95,500 total will be awarded. These dollars are in the BES operating budget ESWS000007.

Portland Opportunities Industrialization Center Engaging At-Risk Youth:

- Staff at Rosemary Anderson High School and Woodlawn School will be involved as students participate in projects.
- Portland Parks & Recreation (Parks) staff (City Nature East) will provide technical expertise to the project and coordinate restoration activities.
- This project builds on restoration work done by BES Revegetation group in the past decade.

PCC Sylvania Habitat Restoration Team Natural Area Park Restoration and Education:

• Parks staff (City Nature West) coordinates restoration activities in the Sylvania Nature Park and provides mulch and staff assistance.

Friends of Tryon Creek Watershed Restoration Mentor Program:

- OWEB is supporting this project with a small grant.
- BES provides technical assistance to landowners.

Pilgrim Lutheran Church Rain Garden:

• East Multnomah Soil and Water Conservation District grant is pending for an expanded project.

Gilbert Park School Outdoor Learning Area:

- Portland Parks SUN school staff will provide naturescaping education and coordinate garden maintenance volunteers.
- David Douglas School District staff will provide project coordination.

Groundwork Portland Green Teams:

- East Multnomah Soil and Water Conservation District grant is pending.
- Environmental Projection Agency grant (\$500) is providing additional project support.

- BES staff will help coordinate on-the-job education and skill building activities and lead educational bioaccumulation activities.
- Parks staff will help lead activities and coordinate projects in park properties.

Franklin Gardens Nature Trail:

- Portland Public Schools staff coordinates student involvement, and provides permission for building use.
- Parks SUN school staff lead garden activities.

Tabor Commons Sustainable Stormwater Display Shelter:

• East Multnomah Soil and Water Conservation District PIC grant is pending.

Beach School Stormwater Gardens:

- BES Clean Rivers Education Program is providing classroom and field education at the site.
- BES Stormwater Retrofits is providing technical assistance and signage to the project.

Depave Word & Spirit Church Parking Lot Greening:

• BES Stormwater Retrofits is providing technical assistance to the project.
