> This almost BILLION dollar (with interest) water project:

> Lays miles of pipe which we don't need, but could be used in the future for blending Willamette

> River water with Bull-Run water.

> Will drain Mt.Tabor and Washington Park reservoirs, leaving Portland with 170,000,000 fewer gallons of water per year in city limits.

> Will pay to build new covered reservoirs at Powell Butte and Kelly Butte, although we DON'T NEED NEW RESERVOIRS WHICH COLLECTIVELY WILL HOLD LESS WATER.

> Covered reservoirs can trap radon, which is found underground in various parts of Portland, in the water. There is radon in our COVERED Columbia South Shore Wells, which is our back-up water supply. Radon naturally vents into the air through our open reservoirs.

> Covered reservoirs create dark, warmer, still water conditions, more ideal for growing cryptosporidium, and more prone to nitrification, a build-up of nitrates and nitrites in our water. Los Angeles has had trouble with nitrification in their recently covered wells. Nitrites can be deadly to infants and the immuno-compromised. Open reservoirs are oxygenated by the sun, which stops nitrite build-up.

>

> Will not stop a determined terrorist! Our water comes from Mt. Hood and Bull Run watershed, both too big to cover. Let's spend a fraction of this money on better monitoring and watershed protection!

>

> Will not stop cryptosporidium:

> Crypto are so tiny hundreds of thousands of them can fit on a grain of sand. The EPA has admitted we do NOT have a crypto problem. Only a small amount of these organisms have EVER been found in our water. And these few were not tested to see if they are a pathogenic species which could harm us- others will not. Bull-Run is oligotrophic, meaning low in nutrients, so it can not even support many organisms.

>

> Our very own UV plant in the sky helps to kill disease causing organisms! Water is cleaned and treated by photo catalysis, or sun-exposure, in communities around the globe! Even when the sun is not shining, UV rays are striking the Earth from our Sun! with no carbon footprint!

> In 2011, President Obama mandated all federal agencies review and remove if possible, onerous financial community burdens from regulations. In response, EPA head Lisa

Jackson has waived a billion dollar covered reservoir project in New York. Our governor, senators, reps and city officials could ask for the same waiver, BUT they REFUSE! Instead they are giving up and saying, oh well,we don't need this billion dollar water project, but we are just going to have to do it anyway!

> The Fact is: the EPA is VERY likely to grant us a waiver, as we have the hungriest state in the nation, 9.2% unemployment rates, and we already some of the highest water/sewer rates in the nation!

> What is at stake? Small businesses everywhere. Seniors, the poor, going without a home water supply. Middle income families being priced out of Portland. And our very own public water supply, Bull-Run, which consistently has provided some of the best quality water in the nation.
