

**Amendment Number 5**  
**PORTLAND STREETCAR OTHER SERVICES AGREEMENT**  
**BETWEEN**  
**TRI-COUNTY METROPOLITAN TRANSPORTATION DISTRICT OF OREGON**

**CITY OF PORTLAND**

This Amendment, dated this \_\_\_\_\_ of \_\_\_\_\_, 2012, is made and entered into by and between the Tri-County Metropolitan Transportation District of Oregon (TriMet) and the City of Portland (City).

**RECITALS:**

On May 2, 2001, the City and TriMet entered into the Portland Streetcar Other Services Agreement (Other Services Agreement No. 51545), subsequently amended to extend the term to June 30, 2012.

On April 19, 2001, the City and TriMet entered into the Portland Streetcar Funding Agreement (Funding Agreement No. 51529) for TriMet to provide funding assistance for the operation and maintenance of the Portland Streetcar System, subsequently amended to provide additional resources for the RiverPlace, Gibbs and Lowell extensions and to extend the term to June 30, 2012.

On April 19, 2001, the City and TriMet entered into the Portland Streetcar Personnel Agreement for operations of the Portland Streetcar (Personnel Agreement No. 51530) for the provision of certain contract employees to work for Portland Streetcar, subsequently amended to extend the term to June 30, 2012.

The City and TriMet are working together to execute during Summer 2012 a Master Agreement setting forth their collaborative relationship in Streetcar service and system development, accompanied by an Operating Agreement which will update and succeed the 2001 Funding, Personnel and Other Services agreements, and which will reflect expanded Streetcar Loop project service beginning September 2012.

In order to provide for uninterrupted operations of Portland Streetcar until the new Master Agreement and Operations Agreement are approved, the City and TriMet wish to execute this Amendment 5 to the Portland Streetcar Other Services Agreement, to extend the term of the 2001 Other Services Agreement by two months, to August 31, 2012.

**AMENDMENTS:**

The referenced sections below is amended as follows: :

1. Term. The term of this Agreement shall extend to August 31, 2012.

ALL OTHER PROVISIONS OF THIS AGREEMENT CONTINUE AS SET FORTH.
