

ORDINANCE No. 185451

Provide confidential treatment for complainant names and contact information submitted to the Bureau of Planning and Sustainability, as allowed under Oregon law. (Ordinance.)

The City of Portland ordains:

Section 1. The Council finds:

1. PCC 17.102.030 authorizes the Bureau of Planning and Sustainability to enforce the provisions of Chapter 17.102, Solid Waste & Recycling Collection.
2. The Bureau of Planning and Sustainability's enforcement program relies upon confidential complaints to initiate investigations into alleged rules infractions.
3. The Oregon Public Records Law allows information submitted to the City in confidence, and not otherwise required by law to be submitted, to be considered confidential. Staff recommends that the City Council approve the Administrative Rule as shown in Exhibit A.

NOW, THEREFORE, the Council directs:

- a. The administrative rule developed by the Bureau of Planning and Sustainability addressing confidential treatment for the names and contact information of persons contacting the Bureau with concerns regarding enforcement of Chapter 17.102, Solid Waste & Recycling Collection is adopted.
- b. Exhibit A to this ordinance is adopted as a binding city administrative rule.



