Answer: Beginning July 1, 2012, the annual fee for facilities on poles in the streets will increase from \$5,000 to \$7,500 per pole per year. Clear Wireless LLC presently has 19 sites in the streets, so at the new rate, revenue will be about \$142,500 per year if no new facilities are added. Clear Wireless LLC will also submit a \$2,000 application fee to OCT each time it requests new facilities on poles in residential areas.

I. RECOMMENDATION. Extend the term of the temporary, revocable permit through January 31, 2013.

> BACKGROUND. Over the last seven years the City Council has granted several wireless right-of-way agreements. The general approach has been to have these agreements expire in 2012 to allow the City to develop consistently applicable terms and conditions. City staff has now reviewed all of these wireless right-of-way agreements, and worked with citizens (see Section VII below), the wireless industry, and the utility pole owners, in an effort to standardize and modernize the terms and conditions of all wireless right-of-way agreements.

II. FINANCIAL IMPACT. The city will continue to receive franchise fees from this wireless carrier's use of the streets. There will be an increase to \$7,500 per year per wireless site in the right-of-way. As Clear Wireless LLC currently uses 19 poles, its fees will increase to \$142,500 per year. In addition, when carriers use poles in residential areas they will now need to provide a one-time fee to OCCFM in the sum of \$2000 to cover increased staff costs.

- IV. CONTROVERSIAL ISSUES. The amendments address the need to provide a better balance between the need for maintaining the character of residential neighborhoods against the need to increase antennae in those areas to increase the provision of wireless services. Compensation for street use is being raised, but industry has been consulted and a special meeting held with them to discuss it. Because wireless is a rapidly growing area the extension is for another three years, after which another evaluation of terms, including compensation, can occur.
