

ORDINANCE No. 185481

Authorize a Local Agency Certification Program Agreement with the Oregon Department of Transportation for the administration of federal-aid capital improvement projects. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. On September 7, 2005, by Ordinance No. 179568, City Council authorized an intergovernmental agreement with Oregon Department of Transportation (ODOT) that authorized the City to participate in the Local Agency Certification Program for federal-aid projects.
2. The agreement required the City to successfully complete a number of Federal Highway Administration (FHWA) funded test projects with ODOT review and oversight.
3. On June 29, 2011, ODOT's Director informed the Mayor that the City's Bureau of Transportation (PBOT) had successfully completed the requirements necessary to become fully certified in the delivery of federal-aid projects through ODOT's Certification Program. City Council accepted the Director's letter by Ordinance No. 184710.
4. Full certification allows the City to proceed with more direct management and oversight of certain federal-aid projects; most significantly, it means that the City rather than ODOT may advertise, bid and award construction contracts for certain federal aid projects.
5. An updated Local Agency Certification Program Agreement has been prepared, acknowledging that PBOT has become fully certified in design, advertising, bid and award, and construction contract administration, and that PBOT is currently pursuing certification in consultant selection for federal-aid projects.
6. The City Council should now authorize the Local Agency Certification Program Agreement for the administration of federal-aid capital improvement projects.

NOW, THEREFORE, the Council directs:

- a. That the Mayor is authorized to execute a Local Agency Certification Program Agreement with the Oregon Department of Transportation, substantially in accordance with the agreement attached to the original of this Ordinance and by reference, made a part hereof.
