

ORDINANCE No. **185507**

\* Extend contract with Cascadia Behavioral Healthcare, Inc. through June 30, 2013 in an amount not to exceed \$105,894 to provide on-scene mental health assessment and evaluation (Ordinance; amend Contract No. 30002518)

The City of Portland ordains:

Section 1. The Council finds:

1. Cascadia Behavioral Healthcare, Inc. currently provides a Qualified Mental Health Professional to ride along with a uniformed police officer in a patrol car to provide on-scene mental health assessment and evaluation as part of the Crisis Intervention Mobile Response Unit.
2. This partnership provides linkage to social service resources and uses the Raintree database to identify and follow up with individuals who are generating frequent police contact due to a mental health or emotional crisis.
3. The City wishes to amend Contract No. 30002518 by extending the term of the agreement through June 30, 2013 and increasing compensation by \$105,894.
4. Funding was awarded as a one-time budget addition to the FY2012-13 Police Bureau Budget on June 21, 2012.
5. Due to the immediate need for a continuation of the FY 2011-12 service contract to prevent a lapse in this program, it serves City and public interest for this ordinance to be in full force and effect immediately upon passage by Council.

NOW, THEREFORE, the Council directs:

- a. The Mayor and Auditor are hereby authorized to execute the agreement substantially in accordance with the agreement attached as Exhibit A.

Section 2. The Council declares an emergency exists because delay in proceeding with the agreement will unnecessarily deprive the City and Cascadia Behavioral Healthcare, Inc. of the mutual benefits of this agreement. This amendment is time-sensitive to the fiscal year and as such cannot afford the longer processing time of a non-emergency ordinance. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
