# **HEARINGS OFFICER'S ORDER**

APPEAL OF David S. Parsons

### DESCRIPTION OF VEHICLE: Dodge Dakota (OR 803EUH)

### APPEARANCES:

### HEARINGS OFFICER: Ms. Kimberly M. Graves

Mr. Parsons appeared at the hearing on his own behalf. No one appeared on behalf of the City. At the start of the hearing, Mr. Parsons requested clarification about the Oregon Revised Statutes (ORS) and portions of the Portland City Code (PCC) related to the tow of vehicles without an insurance card. The Hearings Officer read Mr. Parsons ORS 806.011 which requires a driver to carry an insurance card in the vehicle. The Hearings Officer also indicated that the PCC permits the towing of vehicles which are being operated without proof of insurance. Mr. Parsons then indicated that there was not an insurance card in the vehicle when it was towed, and based on the rules, he no longer believes that he has any argument against the tow of the vehicle. Mr. Parsons indicated that he wished to withdraw his request for a hearing.

# Order:

The appeal has been withdrawn at the request of the appellant.

This order may be appealed to a court of competent jurisdiction pursuant to QRS 34.010 et seq.
