1) Legislation Title:

* Authorize a Grant Agreement with Mt. Hood Community College providing \$38,000 to implement the Future Connect Scholarship program. (Ordinance)

2) Purpose of the Proposed Legislation:

The City of Portland and Mount Hood Community College (MHCC) have agreed to implement the Future Connect Scholarship program from September 2012 – June 2014. The program will provide up to 20 MHCC students with tuition assistance and wrap-around student services designed to eliminate barriers to entering community college and obtaining a college degree or certificate or transferring to a 4-year college or university. Initial scholarships will be awarded to the students for July 2012-June 2013. These students will be eligible for subsequent awards for July 2013-June 2014. This grant agreement provides funds to set up these supports so that they will be in place when the students begin in the fall.
