

ORDINANCE No. **185524** *As Amended*

\*Authorize acquisition of a vehicle for use by Portland Police Bureau (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Council adopted Resolution 35960 to establish a policy for the acquisition of vehicles.
2. Resolution 35960 requires the CityFleet Division of the Bureau of Internal Business Services, OMF, to obtain the approval of the City Council before acquiring certain vehicles.
3. The Police Bureau has been offered a compact SUV through a Judicial Forfeiture process at no cost to the City, Exhibit A attached.
4. The Police Bureau has purchased a mobile law enforcement license plate recognition camera system; the mobile camera system will be mounted to this compact SUV. This will improve the benefits of the new mobile camera system.

NOW, THEREFORE, the Council directs:

- a. The CityFleet Division of the Bureau of Internal Business Services, OMF, is hereby authorized to acquire this vehicle for use by the Portland Police Bureau per the listed request identified in the attached, Exhibit A.
- b. The Bureau of Police will provide annual reports to Council Offices on the results and outcomes of the use of this camera system

Section 2. The Council declares that an emergency exists in order to avoid a delay in acquiring the vehicle; therefore, this Ordinance shall be in full force and effect from and after its passage by Council.
