**1) Legislation Title** \*Amend Legal Services Agreement with Lane Powell for outside legal services to the Bureau of Fire and Police Disability and Retirement.(Ordinance; Amend Contract No. 37745)

**2) Purpose of the Proposed Legislation:** In 2007, FPDR entered into an agreement with the law firm Lane Powell PC on an as needed basis to act as an independent outside general counsel. Lane Powell PC is currently involved in complex issues regarding the Internal Revenue Service and a lawsuit against FPDR. It is critical that Lane Powell PC continue as outside counsel in this litigation. The contract requires an increase of \$200,000 and an extension through October 1, 2017, to continue the work.
