

**ORDINANCE No. 185642 As Amended**

\*Accept a grant in the amount of \$400,000 from the Oregon Department of Transportation for SmartTrips Portland Streetcar (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Bureau of Transportation applied to the Oregon Department of Transportation for a grant in the amount of \$400,000 for SmartTrips Portland Streetcar on October 20, 2011; and
2. The Oregon Department of Transportation has notified the City of Portland that it will award a grant for SmartTrips Portland Streetcar to the Bureau of Transportation in the amount of \$400,000.
3. Grant funds are already shown in the adopted FY 2012/13 budget in TR000175.

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from the Oregon Department of Transportation for SmartTrips Portland Streetcar in the amount of \$400,000 and to execute an Intergovernmental Agreement in substantially the form of the attached exhibit for this purpose.
- b. The Mayor is authorized to execute amendments, approved as to form by the City Attorney, to the scope of the services or the terms and conditions of this Agreement, provided the changes do not increase the City's financial risk. Increases to the grant amount must be approved by the City Council.
- c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
