7. BACKGROUND/ANALYSIS

Scott Sirginson sued the City after he fell off his bike and injured himself. He ran into a cable which was stretched across the dead end street to block traffic from travelling into the remote area where there had been problems of dumping and other crime reported. In the lawsuit, he claimed that the City was at fault for constructing or allowing the cable to remain in the right of way. He injured his wrist and required surgery incurring medical bills of more than \$40,000 and alleged that he could not work because of his injury.

The City Attorney's office and Risk Management negotiated a compromise settlement with 1/3rd contributions to be paid by PBOT, BES and Parks since all three bureaus had contact with the cable in question. Additionally, two property owners in the area were brought into the lawsuit and will contribute separately to the settlement.

8. FINANCIAL IMPACT

Approval of the settlement would result in a payment of \$32,500 from the liability fund.

9. RECOMMENDATION/ACTION REQUESTED

Approve settlement of Scott Sirginson Bodily injury Lawsuit in the sum of \$32,500.
