This legislation generates revenue for the city in the form of grant funds. The total grant is for \$1,725,000 and the source is the Federal Highway Administration. While most of the funds will be awarded to grant partners, a portion (\$200,000) of the funds will remain in the City to cover administrative costs associated with the grant.

The cost is \$200,000, funded by the Oregon Department of Transportation grant. Additionally, the City is providing in-kind match for the grant in the form of staff support and project coordination. The City's match contribution is \$215,000 in staff time and project support

spread over the three fiscal years in which this project is being implemented. The grant revenues and match is included in the FY 12-13 Adopted Budget.
