The Citizen Review Committee Taser / Less-Lethal workgroup report and recommendations seek to influence the policies and practices of the Portland Police Bureau in order to reduce force encounters between police and community members involving less-lethal tools.

b) Which community and business groups, under-represented groups, organizations, external government entities, and other interested parties were involved in this effort, and when and how were they involved?

The Citizen Review Committee Taser/Less-Lethal workgroup began its inquiry in early 2010 and during that two year period met with members of the Portland Police Bureau, attorneys from the Metropolitan Public Defenders Office, members of the Audit Division of the City Auditor’s Office and a representative from the City Attorney’s Office. Workgroup members also received input from community based organizations including Portland Copwatch, the League of Women Voters, the National Alliance on Mental Illness and Disability Rights Oregon.

c) How did public involvement shape the outcome of this Council item?

Stakeholders were able to provide relevant information and community perspective as the project developed.
