Authorize up to \$3.5 million in 10-year interfund capital loans from the CityFleet Operating, Facilities Services Operating, and Technology Services Funds to the General Fund for the reimbursement to the Water Bureau of expenditures for acquisition, construction, and renovation of certain assets; for potential expenses associated with the Willamette Harbor Superfund site, and to transfer management responsibility for certain assets between the Parks Bureau and the Water Bureau. (Resolution)

Authorizes interfund loans between three internal service funds and the General Fund. The loan proceeds will be used to reimburse the Water Operating Fund for expenditures related to certain acquisitions, renovations, and construction of properties; for potential expenses associated with the Willamette Harbor Superfund site, and to transfer management responsibility for certain assets between the Parks Bureau and the Water Bureau.

The General Fund will use these resources to reimburse the Water Operating Fund for expenditures related to certain acquisitions, renovations, and construction of properties; for potential expenses associated with the Willamette Harbor Superfund site, and to transfer management responsibility for certain assets between the Parks Bureau and the Water Bureau. The loans will be repaid with General Fund discretionary resources.
