I. RECOMMENDATION

Approve legislation

II. BACKGROUND

The City of Portland owns and maintains the Tryon Creek Sewer which was constructed in the early 1960's and now requires maintenance in order to eliminate leaks and to restore portions of Tryon Creek to promote fish passage and habitat. Environmental Services requires Professional, Technical and Expert services to identify and design solutions and to provide assistance during construction of sewer maintenance and creek restoration. Consultant selection was conducted in accordance with Chapter 5.68 of the Code of the City of Portland. BergerABAM was selected as the best qualified firm to provide these services. (Scoring sheet attached).

A future contract amendment is planned upon completion of the Design Phase to cover cost of consultant inspection services during construction. No contract amendments are anticipated to change the scope of work. However, given the extraordinary nature of the Tryon Creek site and existing sewer structures, and past experience working in similar sensitive areas, risks to the contract include:

- Physical conditions discovered during the assessment of the existing structures could impact the consultant's level of effort;
- Property easement or permits of entry may require unanticipated design revisions;
- Resolution of constructability and or permit issues and coordination with BES
 Construction Services during design development could require more effort than
 originally anticipated;

- Project priorities for the overall sewer conveyance system may change that could require acceleration or deferral of the project that could impact the consultant's level of effort.

III. FINANCIAL IMPACT

The contract amount is \$471,410.00 These funds are available in the Sewer System Operating Fund, FY-2012-2013 Budget, Bureau of Environmental Services, Center Code 145-22-110, Project Number E10251, Account 521000.
