

ORDINANCE No. 185753

Authorize a request to seek a new contract for Sludge Processing Polymer at the Columbia Blvd Wastewater Treatment Plant (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. That the Bureau of Environmental Services may seek a new contract for Sludge Processing Polymer.
2. Approves seeking a contract for Sludge Processing Polymer at the Columbia Boulevard Wastewater Treatment Plant
3. The established cost is \$\$660,000 annual estimated cost. Funds are available in the Sewer System Operating Fund, FY 2013 Budget, Bureau of Environmental Services, Cost Center is ESWW000009/9ESWWCSLO001.

NOW, THEREFORE, the Council directs:

- a. The Commissioner of Public Affairs is authorized to execute a contract with [TBD] for the purpose described in Section 1, in the amount of \$660,000 annual estimated cost.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
