

ORDINANCE No. 185755

Authorize a contract with GHD, Inc. for professional services for the Schmeer Wastewater Pump Station Upgrade Project No. E07448 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Environmental Services (BES) has need of a consulting engineering firm to provide professional engineering services for the Schmeer Wastewater Pump Station Upgrade, Project No. E07448.
2. Consultant selection has been conducted in accordance with Chapter 5.68 of the Code of the City of Portland (QBS/RFP BES129). The consultant selection committee recommends that GHD, Inc. (GHD) be retained to provide the required professional engineering services.
3. The estimated cost is \$361,750. M/W/ESB participation is \$203,523 or 56% of the total contract amount. Funds are available in the Sewer System Operating Fund, FY2013 Budget, Bureau of Environmental Services, WBS Element E07448.

NOW, THEREFORE, the council directs:

- a. The Commissioner of Public Affairs is authorized to execute a contract with GHD, Inc. for the purpose described in Section 1, in the amount of \$361,750.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.


