- 5. Purpose of Agenda Item: This report provides a one-year update on Portland's new curbside collection service, which included weekly collection of food scraps for composting along with yard debris and the switch to every-other-week garbage.
- 6. History of Agenda Item/Background: City Council adopted the Portland Recycles! Plan (PR! Plan) in 2007 that directed implementation of new residential recycling and composting programs. The second phase of the plan, which launched October 31, 2011, introduced weekly curbside food scrap collection and changed residential garbage collection to every-other-week (EOW).
- 8. What individuals or groups are or would be supportive or opposed to this action?
  No groups are expected to be opposed to a report on this policy. Various stakeholders would be supportive of a report on this policy including environmental and conservation organizations.
- 9. How does this relate to current City policies? This report summarizes progress on Portland's new curbside collection service, set in place by Ordinance No. 184821 in



August 2011. City Council adopted the Portland Recycles! Plan (PR! Plan) in 2007 (Resolution No. 36525) that directed implementation of new residential recycling and composting programs.
